## **GENERAL DEFINITION:**

Under the general supervision of the Maintenance Director, the Maintenance Technician performs a variety of work in the general maintenance and repair of ZHA rental units, ZHA office buildings, and equipment.

## **KNOWLEDGE, SKILLS AND ABILITIES:**

- 1. Knowledge of procedures, methods, techniques, materials, supplies, equipment, and tools utilized in performing skilled journeyman level construction, maintenance and repair tasks.

- 4. Ability to operate large maintenance equipment, including tractors and forklifts.
